BIDS

Sinker Station Store #28, Idaho Falls; Bids are due by 12:00 p.m. 3.8.13. Project consists of demolition of an existing gas station and car wash. A new gas station will be built on the existing site after the demolition occurs. The building will be a mixture of wood stud walls with two CMU 2-hr rated walls. The roof will be single ply TPO over open web trusses and the floor will be reinforced concrete slab on grade.

WWTP package 1 SRF interceptor sewer, Fruitland; Bids are due by 2 p.m. 3.14.13 to the City of Fruitland. The project involves the supply and construction of a gravity sewer pipeline, manholes, and existing pipe reconstructions. All parts of work not specifically mentioned which are necessary in order to provide a complete installation shall be included in the bid and shall conform to all local state, and federal requirements. The project requires all applicable David-Bacon funding requirements as identified within the contract documents.

Annual Trail Maintenance, Orofino; Bids are due by 2 p.m. 3.27.13 to the owner. The Nez Perce-Clearwater National Forest has a need for contractors to perform annual trail opening and maintenance on Forest Service trails. Multiple awards are expected to result from this solicitation. Task orders will be placed throughout the contract period.
